### **Course Objectives**

- To prepare students to be successful in the Calculus sequence at UA (Math 124, 129 and 223)
- To help students develop and refine basic algebra skills by way of an integrated review of these skills as they are needed in the course.
- To promote problem-solving and critical thinking skills through the application of algebraic concepts to common situations.
- To enhance learning and understanding of algebraic concepts through the integrated use of graphing calculators.
- To promote and utilize the “Rule of Four”: All concepts are explored algebraically, numerically, graphically and in context with applications.
- To incorporate writing into the curriculum. Through writing about mathematics you will increase your understanding of the mathematical concepts.
- To help strengthen students’ general academic skills.

### **Attendance**

Daily attendance is expected from every student. Students who miss the first two class meetings will be administratively dropped unless they have made other arrangements. In addition, students with more than 3 unexcused absences may be administratively dropped from the course. All holidays or special events observed by organized religions will be honored for those students who show affiliation with that particular religion. ### **Calculators**

A graphing calculator (TI-82, 83, 84, 85 or 86) is required for this course. **Calculators that perform symbolic manipulations (such as the TI-89 or TI-92) cannot be used.** For in-class exams, quizzes, and the final exam, the only programs allowed in your calculator are the EVALUATE and QUADRATIC FORMULA programs found on the Math department website under Academics and on the course webpage.

A Homework/Quiz/WebAssign policy for your section will be posted at an online location to be announced by your instructor.

### **In-Class Exams**

All electronic devices, particularly cell phones, must be turned off during exams. Silent and vibrating modes are not allowed. There will be six in-class exams. Four of these exams will cover the material from the text and two will be algebra tests. All exams are closed-book and closed-notes, and **no calculators** will be permitted for the algebra tests. **The first algebra test will be on Wednesday, September 2.** The exact dates of the other in-class exams will be announced by your instructor. Any questions regarding the grading of exams need to be cleared up within one week after the exam has been returned. Please note that exam scores will **not** be curved and there is **no** extra credit.

### **Missed Exams**

Students are expected to be present for all exams. If a verifiable emergency arises which prevents you from taking an in-class exam at the regularly scheduled time, you must notify your instructor as soon as possible, and in any case, prior to the next regularly scheduled class. Make-up exams will be administered only at the discretion of the instructor. If a student is allowed to make up a missed exam, (s)he must take it at a mutually arranged time. No further opportunities will be extended. Failure to contact your instructor as stated above or inability to produce sufficient evidence of a real emergency will result in a grade of zero on the exam.

## Final Exam

The final exam is a common, comprehensive final given to all sections of 120R. The exam is scheduled on **Monday, December 14, from 8 am to 10 am**. You will also find this time and date under the Final Exam Schedules on the UA website. The location of the final will be announced by your instructor later in the semester. Please do not arrange to leave town prior to this date as this exam will only be given on the date scheduled by the University.

## Tuesday/Thursday class meeting

For those sections with class meetings 4 days a week, one day each week you will have a class period with extended time. This day is Tuesday or Thursday and the class meets for 1 hour and 15 minutes as opposed to 50 minutes. In most cases your Tuesday or Thursday class will meet in another classroom. This day is reserved for lecturing, exams or quizzes, algebra review, worksheets, or for other activities planned by your instructor.

## Students with Disabilities

If you anticipate issues related to the format or requirements of this course, please meet with your instructor to discuss ways to ensure your full participation in the course.
